7C's Swim School, Inc. shall be available for use by the public on a reservation basis subject to the conditions outlined below. The purpose of these guidelines is to standardize procedure and to insure fairness in the rental of the facility. The applicant, if granted the reservation, agrees to read and abide by the following:

1. User agrees to indemnify and hold harmless 7C's Swim School, Inc., its agents, and employees from and against any claims for damages to persons or property arising out of any use of the facility and its premises by user. 7C's Swim School, Inc. assumes no responsibility for any property placed in or about the facility.
2. No oral agreements for the use of 7C's Swim School facility shall be valid. All reservations must be confirmed with full payment, as well as, a written contract, signed and approved by 7C's Swim School, Inc.
3. THE FEE FOR A TWO (2) HOUR RENTAL OF 12 OR FEWER SWIMMERS IS \$150.00/\$170. SHOULD THE NUMBER OF SWIMMERS EXCEED 12; USER AGREES TO PAY AN ADDITIONAL \$50.00. THE FEE FOR A TWO (2) HOUR RENTAL OF 13-25 SWIMMERS IS \$200/\$220. A MAXIMUM OF 25 SWIMMERS ARE ALLOWED FOR A SINGLE RENTAL. PAYMENT IS REQUIRED TO RESERVE RENTAL.
4. Users are responsible for the set-up and clean-up of their rental. Set-up time is 15 minutes prior to the rental. The user should not attempt to gain access to the pool prior to this time. Clean-up time shall last 15 minutes after the reserved rental time. User agrees to leave the premises in a good or better condition than existed prior to their usage. All trash must be disposed of properly. All decorations must be removed. No confetti is allowed.
5. 7C's Swim School, Inc. shall not permit alcoholic beverages to be served on its premises or in the area surrounding the facility. Smoking is not permitted anywhere on the premises. No food, beverages, or decorations of any kind are allowed in the pool.
6. Cancellations should be received as soon as possible to increase the chance of filling your vacated rental reservation. There will be a \$25 fee for rentals cancelled within fourteen (14) days and a \$50 fee for rentals cancelled within seven (7) days. 7C's Swim School reserves the right to cancel this reservation at any time.

NOTE: All of the above rules and regulations are subject to change at any time.
